1. This approval and any certificate of renewal in Form 49 shall be displayed in the approval premises and shall be produced at the request an Inspector, appointed under the Act.
2. If the applicant Wishes to undertake during the currency of the approval the testing of any other category of Ayurvedic, Siddha or Unani drugs it should apply to the approving authority for necessary endorsement as provided in Rule 160-A. This approval will be deemed to extend to the items so endorsed.
3. Any change in the experts or in the person-in-charge of the testing shall be forwith reported to the approving authority.
4. The applicant shall inform the approving authority in writing in the event of any change of the constitution of the laboratory operating under this Form. Where any change in the constitution of the laboratory takes place, the cureent approval shall be deemed to be valid for a maximum period of three months from the date on which the change takes place unless in the meantime, a fresh approval has been taken from the approving authority in the name of the laboratory with the changed constitution.
